**ORDER GRANTING COMPLEX CHAPTER 11
BANKRUPTCY CASE TREATMENT**

The above-referenced debtors (the “Debtors”) filed these chapter 11 cases on June 10, 2009. By order of this Court, these chapter 11 cases are being jointly administered (the “Jointly Administered Cases”). The Debtors also filed a Notice of Designation as Complex Chapter 11 Case on June 10, 2009. After a review of the initial pleadings filed in the case and after hearing arguments of counsel, the Court concludes that the Jointly Administered Cases appear to be Complex Chapter 11 Cases; it is therefore

ORDERED, ADJUDGED AND DECREED that the Jointly Administered Cases will receive treatment as Complex Chapter 11 Cases pursuant to the Local Rules of the

Western District of Texas, and such procedures will be applicable to the Jointly Administered Cases to the extent that they are not inconsistent with the Order Pursuant to Section 105 of the Bankruptcy Code and Federal Rules of Bankruptcy Procedure 1015(c) and 9007 Establishing Certain Notice and Case Management Procedures entered herein.
